

**SUMMARY ANNUAL REPORT FOR
MIDWEST EMPLOYEE LEASING MEDICAL PLAN**

This is a summary of the annual report of the Midwest Employee Leasing Medical Plan (Employer Identification Number 88-0457743, Plan Number 501) for the plan year 01/01/2022 through 08/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with Humana Health Plan, Inc. to pay certain health and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending 08/31/2022 were \$1,780,686.
